ORGANISATIONAL MATTERS

The Executive Committee Meeting of the Union was held on 19th march 2017 at Cuttack. The meeting commenced at 10.30 AM and Com. Sachidananda Nanda President of the union presided over the meeting. Com.Nalini Ranjan Patro, Dy.Gen Secy. Com.Prakash Das, Com. Prasanta Mohanty and Com. Ashutosh Patro E.C. Member of the newly formed committee were absent in the meeting.

Com. Pradipta Ku. Pattanaik, General Secretary of the union conveyed hearty welcome to all the participants belonged to newly formed body of 13th Triennial Term. While summarising the task and challenges adopted by the general Council, he urged upon the new team to contribute their best to fulfill the desire and aspiration of members and rank & file.

The Committee discussed in length about the Federation's call for one day strike on 27th march 2017 against Anti Workmen policy mindset of the Management, to seek improvement in governance in bank and in fringe benefits etc. Committee was informed that Federation had served notice on management and statement of reasons which our union has circulated to all branches vide Cir-5.It was decided to make all out effort to make it successful.

NOTE: BILATERAL DISCUSSION IN CENTRAL COUNSULTATIVE COMMITTEE TOOK PLACE WITH TOP MANAGEMENT ON 22ND MARCH 2017 AT MUMBAI. MANAGEMENT HAD SHOWN POSITIVE RESPONSE TO OUR DEMAND. HENCE STRIKE CALL WAS WITHDRAWN BY THE SMALL COMMITTEE ON THE SAME DAY.DETAIL OUTCOME OF THE DISCUSSION ALREADY BEEN CIRCULATED TO BRANCHES ON 23/03/2017 BY US .

Com. S.N.Nanda ,President in his address appraised the history of the Union, structure, status of All Odisha bank Employees Association, Federation of Bank of India Staff Unions and All India Bank Employees Association. He narrated a brief resume of our rights and responsibilities under legislative frame work of Indian Trade Union Act 1926 and Industrial Dispute Act 1947.He had briefed to all the new entrants to the body about the power and function of Executive Committee. He urged upon all to restore mutual respect and dignity during functioning as well as in the meeting and emphasized that the decision taken by the E.C. either unanimously or by majority is binding on committee Members and members of the union.

Z.C.C MEETING IN BOTH THE ZONE: The meeting was held on 17th March and on 24th March 2017 of Bhubaneswar & keonjhar Zone respectively. Issues such as (a) filling of vacancies of Special Asst. in time, (b) Renovation/ shifting of Sumandal, Haripur, Duburi, Nuasantha, Chhend Hsg. Colony, (c) Provision of basic amenities such as Printer, Drinking water, Air Conditioner etc. (d) Provision of washroom/toilet in FI branches, (e) Requisition for more nos. of Clerks, Sub-staff and Arm Guards from HO. (f) Sanction of all pending overtime payment etc. Management assured to resolve all the issues. It was also assured by the Management to take up all the Intra & Inter Zone transfer on need based manner when new recruitment takes place.

Comrades, we all are aware that Govt. is providing Rs.1500 cr. recapitalization to our bank. They have stipulated that MOU for turnaround the Bank should be signed. In this regard Federation has given detail circular which was circulated to all branches through Branch MMS vide Cir-6 dt.05.04.2017. AIBEA has also taken up the issue with Government and consequent to that Govt. advised the Bank to make changes in the MOU to provide for consultation with the Union and also a specific Note that the interest of the employees and officers will be kept in mind while finalizing the MOU. Any violation of the agreed settlement and changes in benefits should be challenged aggressively. We all should be in preparedness for any eventuality.
