Re: CLARION CALL TO GO ON STRIKE FOR TWO CONSECUTIVE DAYS (24th & 25th February, 2025)

The Executive Committee of the Federation of Bank of India Staff Unions in its meeting held on 9th & 10th December, 2024 at Jaipur, the Steering Committee of the Federation of Bank of India Staff Unions in its meetings held on 5th January, 2025 at Mumbai and an on-line meeting of an extended Small Committee on 10th January, 2025, after threadbare discussion and deliberations, after taking stock of progress made on the outcome bilateral talks following the service of notice of strike dated 12th September, 2024, expressed their deep concerns over the indisputable facts that the management of the bank has been failing in fulfilling their commitments, written- oral, made in joint discussions held on 25th September, 2024 at bilateral level, joint discussion held on 23td & 26th September, 2024 in the august presence of the Deputy Chief Labour Commissioner (Central), HQ, New Delhi and in earlier Bipartisan Committee (called as Central Consultative Committee) meetings at bank level. The meeting was of considered opinion that no sincere effort seems to be underway to deliver on the promises, fulfill the commitments, implement all terms and conditions of the settlement dated 27th December, 2021 in toto and in letter and true sense/ spirit. The meeting further expressed its deep concern over egregious breaches of the provisions of the settlements and/ or the provisions of The Industrial Disputes Act 1947 and/ or The Payment of Bonus Act 1965 and/ or the Minimum Wages Act 1948 and/ or mutually agreed and sanctified Human Resource Frameworks under the settlement dated 27th December, 2021.

In this background, the meeting resolved to take recourse to protest actions in the form of "peaceful demonstration", " peaceful and silent sit-in Dharna", "intermittent Strike actions" and other modes of protest action. The meeting finalized a calendar of protest which is appended below:

2	From 13.02.2025 until further notice	To Withdraw extra cooperation (follow laid down systems & procedures while performing duties) and strictly adhere to prescribed Hours of Work. No late sitting to perform bank's jobs.
3	19.02.2025	To wear Black Ribbon Band, during working hours, to protest against violation of the provisions of the settlements and to demand fulfillment of unfulfilled commitments.
4	20. 02. 2025	To Display Placards, depicting demands, by respective unit in front of all Zonal Office followed by demonstration and Mass Deputation to the respective Zonal Manager (timing to be decided by the respective base union/ association)
5	24 th & 25 th February , 2025	Two consecutive days Stay Out "STRIKE" (Notice of Strike already served on the management of the bank)
